

TERMS AND CONDITIONS: “ATM PRIZE” COMPETITION

COMPETITION RULES

- 1 The “ATM Prize” competition is brought to you by Moneyline Financial Services (Pty) Limited, and OBC Chicken (“**the Promoters**”).
- 2 The “ATM Prize” competition will run from 28 November 2018 to 31 December 2018 (“**the promotion period**”).
- 3 The Competition is open to all EasyPay Everywhere (“**EPE**”) account holders and non-EPE account holders who withdraw funds from an EasyPay branded ATM (“**eligible participants**”).
- 4 Participants must be 18 years or older.
- 5 In order to be eligible for the prizes on offer, eligible participants must withdraw funds from an EasyPay branded ATM located either in a Net1 Financial Services branch or an OBC Chicken store.
- 6 Eligible participants who withdraw funds from an EasyPay branded ATM located in a Net1 Financial Services branch stand a chance to receive cash-back vouchers as follows:
 - a. Every 50th (fiftieth) participant who is the holder of an EPE account holder stands a chance to win a R50 (fifty Rand) cash-back voucher; or

- a. a cash-back voucher will be notified immediately after their withdrawal on the ATM screen and will be prompted to enter their mobile number. Once the winner has entered his or her mobile number a sms will be sent to their number with a voucher code.
 - b. an OBC Chicken voucher will be notified immediately after their withdrawal on the ATM screen. The ATM will print a slip that details a voucher code that will be redeemable from the cashier at the applicable OBC Chicken store.
- 9 In order to redeem any cash-back voucher, winners must select the “Cardless Transaction” option on an EasyPay branded ATM and enter the voucher code they received. The EasyPay branded ATM will then dispense their prize.
- 10 In order to redeem an OBC Chicken voucher, winners must present their ATM slip (that displays the voucher code) to the cashier at the OBC Chicken store where he or she withdraw their funds and the cashier will provide them with either a 1kg pack of chicken livers or a 500g pack of chicken livers (whichever is applicable).
- 11 Cash-back voucher and/or OBC chicken voucher winners must redeem their prizes within 5 (five) days from date of notification. If the winners do not redeem their vouchers within this 5 day period, they will forfeit the prize and the voucher code will no longer be valid.
